### Introduction

We gather and use certain information about individuals in order to provide services and to enable certain functions on this website.

We also collect information to better understand how visitors use this website, to present timely, relevant information to them and occasionally also for the purpose of direct marketing.

## What data we gather

Article 4(1) of the GDPR defines 'personal data' as "any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person".

In practice, this means we may collect data including, but not limited to, the following information:

- Name and job title
- Contact information including email address
- Demographic information, such as postcode, preferences and interests
- IP address

- Website usage data
- The page which 'referred' you to this website (e.g. a search engine)
- Source documents, reference material and translations
- Other information relevant to client enquiries
- Other information pertaining to special offers and surveys

We may also process data which is classed as sensitive information, where this data is contained in documents to be translated or processed as part of the translation or copywriting assignment. This sensitive data may include information about the data subject's physical or mental health, racial or ethnic origins, religious beliefs or trade union membership. By commissioning a translation or copywriting assignment containing personal data, you confirm that the data subject has consented for his/her personal data to be processed to the extent strictly necessary for the assignment to be performed.

## How we use this data

Collecting this data helps us understand what you are looking for from Ignite Translations, enabling us to deliver improved services.

Specifically, we may use data:

- For our own internal records.
